Our University signed a **MoU with Siddhananta Knowledge Foundation, Chennai on 07.10.2025 at 03.00 pm in the Board Room of the University.**

Siddhananta Knowledge Foundation is a Ministry of Education, Govt. of India's IKS Division accredited IKS center. Siddhanta is a pioneer in research and development of courses based on Indian Knowledge Systems, which are suitable and can be integrated into all types of streams in the contemporary education system.

Siddhanta is offering several IKS courses on its Siksha Learning Management System (LMS) and the University has the choice to take any of the courses. In addition, the University/ Institute has the choice to take Foundational, Advanced, Refresher and Discipline-specific Faculty Development Programmes (FDPs) offered by Siddhanta in Indian Knowledge Systems, as may be required from time-to-time.

Based on NEP 2020, the transfer of Indian Knowledge Systems to all the learners in Higher Education is vital and in this regard this MoU will help in the implementation of IKS courses in our University.

The MoU Signing Ceremony started with a Welcome note by Dr. A. Rajan Samuel, Director- Academics, VMRF (DU), Salem who explained the need for IKS training to both the students and Faculty.
