

1. Admissions India

Vinayaka Mission's Research Foundation (DU) Admission Monitoring Committee (VMRFDU AMC) is empowered to undertake joint counselling for admission to all the Programmes offered by Vinayaka Mission's Research Foundation (DU) (all four Campuses). All the programmes offered under each faculty are updated in the University website www.vmrfd.edu.in

1.1 Application

The admission process starts with the application. Applying to VMRF-DU is simple with the following options.

Option 1: Apply online with e-payment.

Option 2: Apply online with DD Payment

Application fee is common for all the Programmes irrespective of Entrance Exam Programmes and Non-Entrance Programmes. Refer www.vmrfd.edu.in to know the last date for submission of application.

1.2 Eligibility:

Who can Apply?

Resident Indians, Non- Resident Indians (NRIs) and holders of Person of Indian Origin (PIO) or Overseas Citizen of India (OCI) card issued by the Government of India are eligible to apply for VMRF-DU

- (i) The eligibility criteria for different programmes under the different faculties are available in the respective regulations available at the website <https://vmrfd.edu.in/Academics.php>
- (ii) The Academic Council of VMRF(DU) is committed to abide by the guidelines and regulations on admission stipulated by the statutory bodies such as University Grant Commission (UGC), All India Council for Technical Education (AICTE), National Medical Commission (NMC), Dental Council of India (DCI), National Commission for Homoeopathy (NCH), Pharmacy Council of India (PCI), Indian Nursing Council (INC), Rehabilitation Council of India (RCI), and National Council for Teacher Education (NCTE) and Bar Council of India (BCI)
- (iii) The eligibility requirements for the various programmes were offered by VMRF (DU) shall be decided by the Academic Council from time to time. The eligibility requirements are subject to change. Normally these are considered and approved by the Academic Council while finalizing the admission policy for each academic session.

1.3.1 VMRF (DU) All India Entrance Examination (AIEE):

The VMRF (DU) All India Entrance Examination (AIEE) and the Counseling will be conducted as per the UGC, INC, RCI and Government Notifications. If the Entrance Examination is not conducted, the admissions will be based on the qualifying examinations. Having been called for the entrance exam and counselling does not necessarily means acceptance of eligibility. It is the

responsibility of the candidates to ascertain whether they possess the requisite eligibility for admission.

VMRF (DU) All India Entrance Examination (AIEE) is being conducted to meet the rising competition amongst the various Universities. It helps to maintain standards both nationally and internationally.

1.3.1.1 VMRF (DU) All India Entrance Examination (AIEE)

1. VMRF (DU) All India Entrance Examination syllabus is published in VMRF(DU) official Website
2. VMRF (DU) All India Entrance Examinations will be conducted in Remote Proctored Online Mode (RPOM) & off line mode.
3. The date and time, once allotted to the candidates shall not be changed under any circumstances.

1.3.1.3 Entrance Examination Process

VMRF (DU) All India Entrance Examination will be conducted in Remote Proctored Online Mode (RPOM) / Physical Mode across the centres. Remote proctoring is a method of carrying out invigilation through online or digital means of an online examination taken by a candidate from any location of choice. In other words, remote proctoring emulates the role of an onsite proctor which comprises confirming identity of the candidate, smooth conduct of the examination which is taken by the candidate on his laptop/desktop using the internet and assessed by an offline proctor. Usage of mobile phones for taking up the examination is strictly prohibited.

The Standard operating procedure lays down the guidelines for remote proctoring to be followed by the candidates and remote proctors.

1.3.1.4 Registration process:

Each candidate will be assigned to a proctor who will monitor the candidate continuously via web camera activated in the candidate system. Requirements for the remote proctoring examination will be shared to all the registered candidates.

1.3.1.5 Hall Ticket

- 1.** The e-hall ticket/hall ticket will be issued only to those eligible candidates who have submitted their application form complete in all respects, on or before the last date as specified.
- 2.** The hall ticket will contain the name, photograph, DOB and Examination Centre of the candidate and the examination schedule.
- 3.** The hall ticket should be downloaded from the candidate's login / dashboard from the Online application portal.
- 4.** Once downloaded, it should be carefully examined by the candidate. If any discrepancy is noticed it should immediately be brought to the notice of the Director (Admissions), VMRF-DU.

The hall ticket is not transferable to any other person. Impersonation is a legally punishable offence.

The Last date to apply for VMRF(DU) All India Entrance Examination different phases will be announced in the website: www.vmrfd.edu.in and the student can write in either of the phases.

The seat allocation will be done equally for all phases or depending on the number of applications and the decision may be reached at that point of time.

Candidates who have not appeared for VMRF (DU) All India Entrance Examination, are not eligible for admission to that particular Programme. The admission will be purely on merit the basis of the rank secured in VMRF (DU) All India Entrance Examination will be conducted by VMRF (DU)

The Eligible candidates will be called for counseling on the basis of rank at the end of each phase.

1.3.1.7 Results

1. The merit list will be prepared based on the total marks secured in the VMRF (DU) All India Entrance Examination.
2. The examination result and counselling details will be available in the online application portal.

1.3.2 Selection through Qualifying Examination:

- The Merit list will be prepared based on the marks obtained in the qualifying examination and candidates called for counseling.
- Candidates can choose their program in a particular campus fulfilling the eligibility criteria and Subject to the availability of seats at that point of time

1.3.3 Department level Selection:

Preliminary scutinisation of all applications received online will be done and candidates called for Department level examination/Interview. Based on the Examination/Interview, a merit list will be prepared and candidates will be called for counseling. Admission is based on: Fulfilling the eligibility criteria and Subject to the availability of seats at that point of time.

1.3.4.1 NEET (UG/PG) (for the programmes offered under Faculty of Medicine and Faculty of Dentistry)

NEET (NATIONAL ELIGIBILITY CUM ENTRANCE TEST) UG will be conducted by National Testing Agency (NTA) and NEET PG / NEET MDS will be conducted by the National Board of Examinations for admission to MBBS /BDS/ MD/MS/MDS Degree Courses is approved/recognized Medical / Dental Colleges / Institutes in India.

Admission to MBBS /BDS/MD/MS/MDS Degree Courses under VMRF (DU) Constituent Colleges will be allotted through Common Counseling by the MCC of Director General of Health Services, MHFW, Govt. of India, New Delhi. Those candidates, who got allotment for admissions, should report to the respective Deans as per the schedule issued by the MCC of DGHS.

1.3.4.2 NEET (UG)/AIAPGET (for the programmes offered under Faculty of Homoeopathy)

NEET (NATIONAL ELIGIBILITY CUM ENTRANCE TEST) UG/AIAPGET will be conducted by the National Testing Agency (NTA) for admission to BHMS/MD (Hom.) Degree Courses are approved/recognized Institutes in India.

Admission to BHMS / MD (Hom.) Degree Courses under VMRF (DU) Constituent College will be allotted through Online counselling by the AACCC (AYUSH Admissions Central Counseling Committee). Those candidates, who got allotted for admissions, should report to the respective Principal as per the schedule issued by AACCC.
